

Calculating Time with Noncustodial Parent

LEGAL FACTORS:

1. Fam C §4055(b)(1)(D): Support payment decreases as timeshare increases.
2. AFDC eligibility, federal and dependency exemption and state dependent credits, head-of-household filing status, child care and earned income credits: available when timeshare exceeds 50%.
